Objectives of the Foundation

- To arrange and organize conference, meeting etc from time to time for discussion of various problems of the members of the Foundation,
- To help the people in marriage, funeral and cremation of the dead.
- To help the aged, sick, helpless and indigent persons.
- Relief times of famine, flood, draught & earthquake.
- To uplift street children in the aspect of education, social culture and moral development.
- To start free ambulance services to help the people in need.

Project “Uttoron”

- Around October 2022, project Uttoron was started with two schools in Haringhata.
- Scope was to augment their regular education by engaging a teacher to teach them English and Maths in the evening
 - Around May 2023, one of the schools (Mollabelia) had to be discontinued due to lack of support from the school management.
 - The other school (Adibasipara, Thakurtala) has been doing well. We also have ‘Galpogachha’ running there.
 - Apart from regular studies, cultural programs are organized from time to time
 - We supported a few students who wanted to appear for some competitive (talent search) exams
 - A few students needed help with admission to high school, that has since been provided.
 - We provide school stationeries at the beginning of the academic year & new clothes during Durga puja.
 - Lunch event sponsored by patrons (acquaintance of foundation members) were arranged
 - Overall, this school has been a major success story for us, till date
 - In this school, we also provide evening snacks to the students

Project “Uttoron”

- In Jan’2024, we started two schools in Budgebudge
- The model was different – they needed full time teachers, as some of the primary schools are down to just one teacher, who also ends up spending most of her time on administrative work
- Out of the two schools, one of them (Bhetkakhali) closed down almost immediately, as the teacher appointed by us never turned up (basic commitment issue).
- The other school (Mohanpur) started well, however even though we wanted the teacher to focus only on third and fourth grade, and engage in academic activities alone, very soon we found that she got sucked into school administrative work. With virtually no support from the BDO, there was little we could do to change. As there was no real value add, we decided to discontinue this school also in Dec’2024.

Project “Uttoron” – charting out the next steps

- Some challenges that we faced (and learned from them):
 - New BDO's (who came in after transfer) don't seem to be taking interest, even when they are not specifically stopping the projects
 - Most cases, interest from school and students are on the lower side
 - Managing remotely continues to be an issue [esp. getting good teachers with some level of commitment is a challenge]
 - Most importantly, WB Government has plans to overhaul the primary education structure – more Government control expected to replace current setup of SSK's managed at BDO/Panchayat level
 - While we have a working model and wish to scale up to more schools, it is not clear whether this will sustain for a long time.
- Alternate models:
 - Working in the same space but without entirely depending on Government agencies is likely to be more sustainable. There are like-minded organizations, and it is possible to partner with them
 - As a long term goal, we have been thinking about coming up with our own school, and develop that over a period of time
 - While financing the project will be one major area to address, members need to decide on the long term objective of the foundation

“Sopan-Uttron” Partnership

- In Dec'2024, we entered into a formal partnership (MoU signed) with “**Be-and-Make**”, a like minded NGO working in similar space but with somewhat mature process and larger scale, supporting students under an initiative named “**Sopan**”
- Under “Sopan”, more than ten schools are currently functioning across the state
- We are currently supporting two schools under “Sopan-Uttron” joint banner:
 - Bhuipara, Pandua, Hooghly
 - Eklashpur, Malda
- We are bringing Haringhata also under one common process (learning methods, activities, monitoring & assessment, reporting), with support from Be and Make staff

Project “Uttoron” - Tracking

- Project coordinators make frequent field visits, foundation members visit on specific occasions (inauguration, parent teacher meet, cultural program, launch of ‘Galpo-gachha’)
- Teachers enter daily logs online (Google form), capturing data related to attendance, content covered, major issues
- Project coordinator creates (and circulates) monthly reports where basic metrics are captured.

Computer lab in Rahara Ashram

- The project, started in 2019, had to be stalled due to COVID pandemic.
- Classes resumed from Jan 2023.
- However, largely due to lack of interest and support from school authorities (too academically focused, also schedule controlled by mid-layer staff), classes were discontinued and project closed from around June 2024.
- School authorities will decide how best to utilize the lab
